In the fall of 2016, ESMMSC launched a Healthier Food Choices in Public Places campaign, which encourages South Carolina cities and counties to adopt evidence-based nutrition standards for all foods and beverages sold in public vending machines, including in parks, recreation centers, community buildings, and offices. Campaign partners include the American Heart Association and SC Hospital Association. In addition, ESMMSC is working closely with the SC Commission for the Blind Business Enterprise Program to support blind vendors with implementation resources.

4b (Code:) (Expenses \$ **402,357** including grants of \$) (Revenue \$ **42,962**)

The Let's Go! South Carolina Community Initiative expanded into six counties with support from BlueCross Blue Shield of South Carolina Foundation, an independent licensee of the Blue Cross and Blue Shield Association. We also launched LetsGoSC.org, featuring an interactive map that pinpoints inexpensive or free options for healthy eating and physical activity across the state.

We strengthened and expanded the Healthy Young People Empowerment (HYPE) Project with support from SC DHEC and SC Institute of Medicine and Public Health. Technical assistance and support were provided in several counties to integrate and connect HYPE teams to existing local coalitions - a strategy to strengthen influence and maximize efforts of positive change.
