Second, we support efforts on community health improvement and injury and violence prevention, through our work in marketing and youth engagement.**

**The Let's Go! 3.0 Mini-Grant Community Initiative was launched in 2019 with support from the Blue Cross Blue Shield of South Carolina Foundation, an independent licensee of the Blue Cross and Blue Shield Association. Investments in local communities include healthy eating active living technical assistance from ESMMSC staff, coalition trainings, public health professional development, and healthy eating active living policy, systems and environmental projects across the state.**

**In Fall 2018, ESMMSC launched a SNAP Incentive campaign to support Healthy Bucks, a program administered by the SC Department of Social Services. ESMMSC supports the efforts of Healthy Bucks in SC because it helps connect people with healthy foods, supports local farmers and the economy. Campaign partners included a national partners, the American Heart Association, and many local and statewide organizations (farmers, farmers markets, Farm Bureau, SC Food Policy Council).**
